THIS IS A LEGAL AGREEMENT

by downloading and/or installing Monoco Type Foundry Fonts you agree to the following terms and conditions:

### 1. ALLOWED USE

You may use TRIAL Fonts for creating graphics that displayed on a computer screen for creating graphical images, products, printouts, paper documents for testing and evaluation purpose only. Before using the Font Software to create products/visuals to be used commercially, or personally, you must purchase our retail licenses.

### 2. NUMBER OF TRIAL USERS

Monoco Type grants the Licensee a non-exclusive and nontransferable license for testing, non-commercial work for free to create visual/products for testing and/or evaluation purposes only. The maximum number of End Users using the TRIAL Font Software can be used simultaneously and always within in your company or same household. Trial License does not allow using TRIAL Font Software to create print results that are not for testing purposes.

### 3. THIRD PARTIES

Licensee and/or the users under the same household/company MAY NOT distribute, give, lend, sell, and/or sublicense the TRIAL Font Software and/or make the TRIAL Font Software accessible to other third parties. Sub Licensing and/or license transferring is strictly prohibited. If this happens, the abusers of the agreement will be processed due to the Indonesia Law.

### 4. MODIFICATION & CONVERSION

You are not allowed to modify, customize, translate, reverse engineer, decompile, disassemble or otherwise attempt to locate the Font Software source code.
