[A] DEFINITIONS

- 'Authors' refers to whoever created or contributed to the font software.
- 'Free' font software means a specific font software has been distributed for free and without additional charges.
- 'Paid' font software means a specific font software has been sold for a set price.
- If a statement doesn't include both the terms 'free' and 'paid', it means both terms are mentioned.
- 'Original Work' refers to the original software distributed officially by the Authors.
- 'Modified Work' refers to the modified version of the Original Work. Modification may be adding, removing, substituting certain aspects, or changing file formats.
- If a statement doesn't include both the terms 'Original Work' and 'Modified Work', it means both terms are mentioned.

[B] AGREEMENT

By purchasing or download a product/ package from RandomMaerks or their Authors, you must oblige to the following terms:

[1] Use

1.1. You can use the font software for personal use and commercial use.

1.2. You can use the font software to create:

- * Graphical designs, such as: logos, mockups, etc;

4.4. You may not re-distribute the paid font software, unless given RandomMaerks' or the Authors' consent.

If you fail to comply with or do not agree to the Terms above, you must remove all copies of the related font software from all devices.

The font software is provided 'as is', without a warranty of any kind, express or implied, including but not limited to any warranties of merchantability, fitness for a particular purpose and noninfringement of copyright, patent, trademark, or other right.
